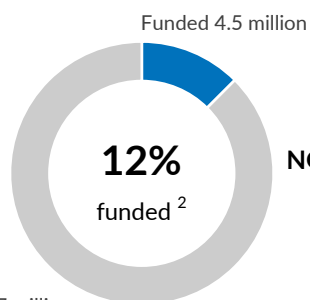

3. Contributions are shown by the level of flexibility in the earmarking. Contributions earmarked to a situation within a country are classified as country level.

The broadly earmarked contributions listed are those which can potentially be used for the North of Central America Situation due to their earmarking to a related region, sub-region, country or theme. The total amount of the contributions is shown for donors who have contributed \$2 million and more.
5. The total amount of unearmarked contributions is shown for donors who have contributed \$10 million and more.
