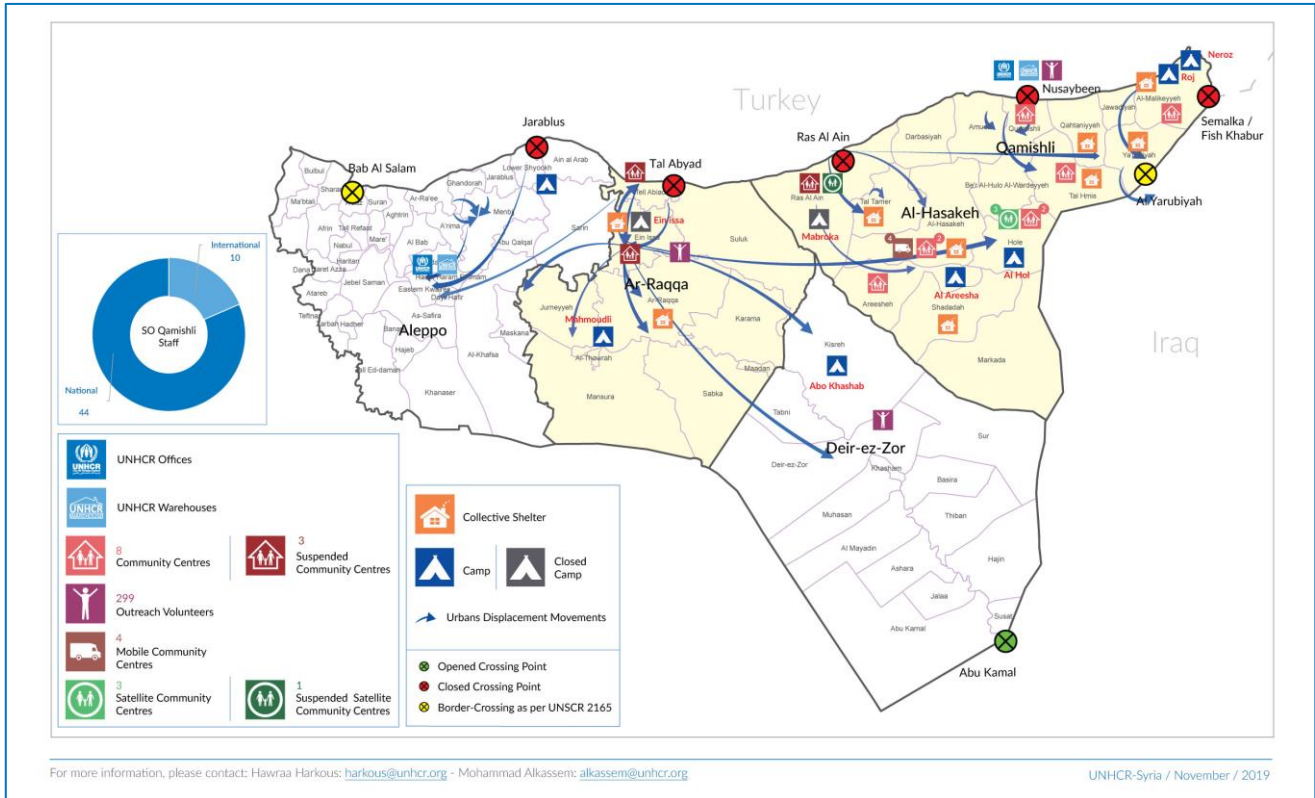


UNHCR SYRIA SITUATION REPORT FOR THE NORTH EAST SYRIA HUMANITARIAN EMERGENCY

As of 17 November 2019

- As of 12 November, 220,180¹ population movements have been recorded since the military operations began on 9 October.
- 74,381 people remain displaced from Hassakeh (48,134), Raqqa (19,471) and Aleppo (6,776) governorates.
- 117,132 people have returned to their areas of origin in Hassakeh (65,210), Raqqa (41,817) and Aleppo (10,105) governorates, while 28,667 people were displaced more than once.
- Overall, 91 active collective shelters in Hassakeh (90) and Raqqa governorates are accommodating 16,961 – an additional 32 collective shelters, all in Hassakeh governorate, are now empty.

Emergency response update



Protection concerns and response

- **13,241 individuals** accommodated in 57 collectives shelters and host communities in Hassakeh, Tal Tamer, Tal Hamis, Qamishli, Malikiyah, Raqqa have been reached by UNHCR protection partners with an array of protection activities, including recreational activities for children, GBV prevention sessions, PSEA session, PSS, case management and general/medical in kind assistance for persons with special protection needs.
- SARC conducted legal awareness session in five collective shelters during the week.



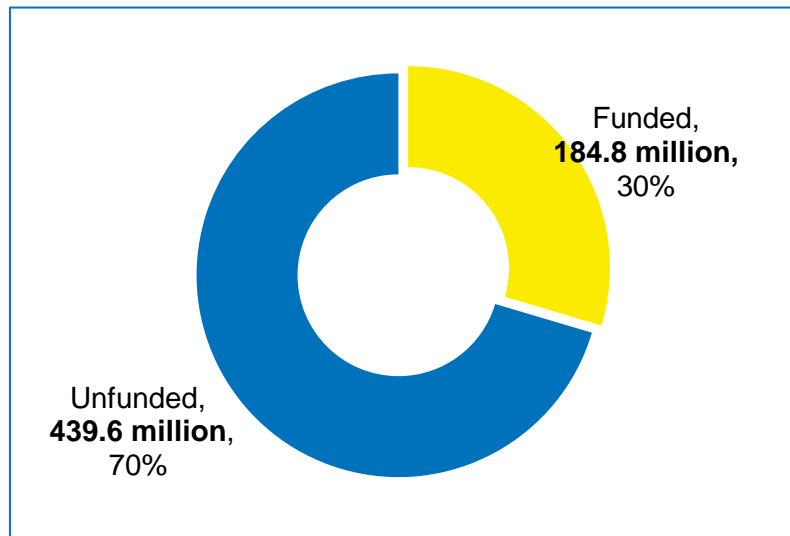
NFI and shelter response

- UNHCR has reached **174,229 individuals** with core relief and winter items.
- Winter distributions have already reached **86,737 people** in Al Hol, Areesha, Ain Issa before it closed, Roj and Mahmoudli camps. This includes NFIs for new arrivals.
- NFI distributions are ongoing in urban areas and collective shelters to IDPs and host community in Hassakeh, Mabada, Qamishli and Tal Tamer. **To date, 87,492 individuals in 160 locations** in Hassakeh, Tal Tamer, Mabada and Qamishli have received NFI assistance.
- UNHCR has completed basic shelter repairs in **18 shelters benefitting 847 families** and work is ongoing in another 13 shelters for 665 families and assessment planned in another 14 collective shelters with 512 families. Partners have also repaired 12 shelters and planning additional 17 shelters.

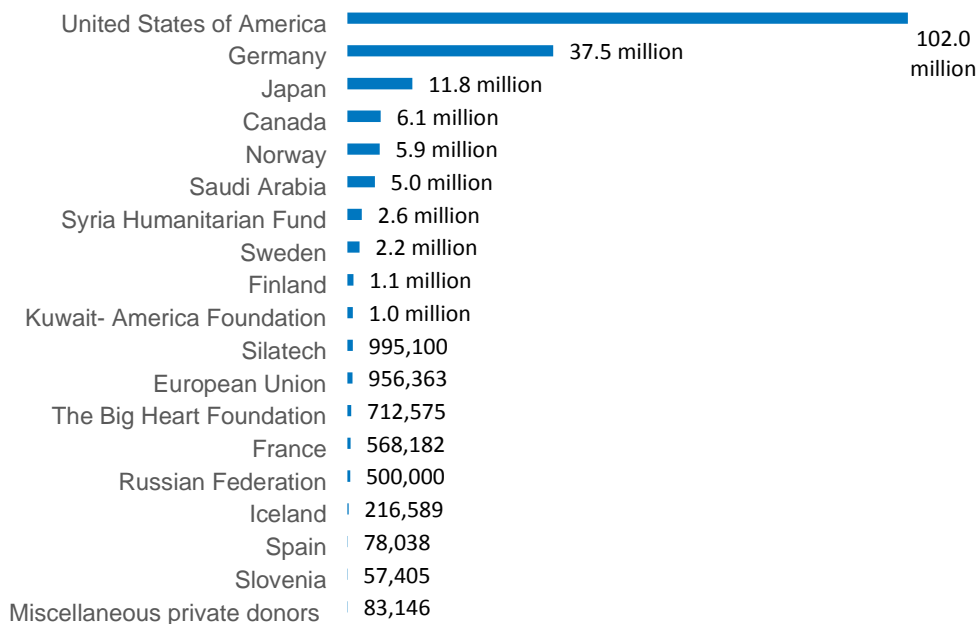

UNHCR's 2019 total financial requirements for Syria is USD 624.4 million. As of 11 November, only USD 184.8 million has been received; 30 per cent of the total requirements.
