CRITICAL GAPS IN FUNDING NEEDS FOR SYRIAN REFUGEES LEBANON AND JORDAN

UNHCR's response to the needs of **Syrian refugees** is critically underfunded, with additional contributions required to avoid dramatic cuts to essential and life-saving services to Syrians in the second half of the year. As of 1 June 2017, the total funding gap exceeds USD 1 Billion for 2017 and within this gap, **USD 187 Million** is needed most urgently, **as per the breakdown of needs outlined below for Lebanon and Jordan.**

The following are examples of assistance programme and services that will be affected if additional funds are not made available immediately.

- **UNHCR in Lebanon urgently needs 116 million** for essential and life-saving services: multi-purpose cash for 30,000 households for five months, winter cash for two months for 174,000 households; protection cash assistance for 1,500 households; 65,000 life-saving secondary health care interventions; and support to UNHCR's and the General Security Office's (GSO) capacity to issue and renew refugee documentation.

- **UNHCR in Jordan urgently requires USD 71 million** to provide monthly cash assistance for 30,000 Syrian families; support to the estimated 60,000 Syrians stranded at the Syria-Jordan border; 115,000 primary health consultations and 12,000 referrals to secondary health care services for refugees in camps and urban areas; and winterization programming to support 35,000 Syrians.

OVERALL NEEDS FOR SYRIAN REFUGEES AND IDPS

The Syria situation remains underfunded despite urgent needs and additional funds are needed in Syria and in Turkey.

In Syria, funding is requested to respond to fresh displacement, particularly in Ar-Raqqa, East Ghouta and Der Ezzor where new camps need to be set-up for roughly 45,000 newly displaced. And with ongoing IDP returns in various parts of the country, UNHCR is supporting people to repair their homes and providing basic household items. **UNHCR in Syria needs USD 37 Million for this purpose.**

In Turkey, the provision of winter cash assistance and items are among the main priorities for the next six months, as well as, support to community centres which offer legal assistance and counselling, and, support to government authorities on registration and verification of refugees. **UNHCR in Turkey will need USD 34.5 Million for this purpose.**

FUNDING GAP

Overall, more than **USD 1 Billion** is still needed for the Syria Situation, including **USD 187 Million** for the most urgent needs in Lebanon and Jordan

WITHOUT URGENT FUNDING

60,000 Syrian refugee families will be cut from monthly cash assistance programmes in Lebanon and Jordan as early as July.

209,000 Syrian refugee families will not receive winter assistance this year in Lebanon and Jordan.

192,000 primary and secondary health consultations will not be supported for Syrian refugees in Lebanon and Jordan.

UNHCR's 2017 financial requirements for protection and assistance to Syrian refugees outside and inside Syria amount to **USD 1.6 billion**. As of May 2017, **USD 568 million** has been received.
