

Southern Syria Emergency: Supporting the Urgent Needs of Civilians Displaced

02 July 2018

Overview

As hostilities escalate in southern Syria, civilian deaths continue to be reported and tens of thousands of people have already been displaced. Reportedly, the majority of the displaced fled from eastern Dara'a governorate towards the Jordanian border, many of whom remain stranded in the desert area with little access to humanitarian assistance. Thousands of others have fled towards Quneitra governorate and others have reportedly fled to Syrian Government-controlled areas in As-Sweida governorate. Inside Syria, there will likely be five different modality settings in which the affected population could be reached: (i) Cross-border from Jordan; (ii) IDPs in collective shelter settings; (iii) IDPs and affected people in host communities; (iv) Syrians residing in areas that saw a recent shift of control; and, (v) cross-line operations for IDPs who remain in opposition-controlled areas. Overall planning scenarios suggest that up to 300,000 individuals could be displaced in south-west Syria, with up to 20,000 people possibly being given access to safety in Jordan.

Syria – USD 38.1 million for protection, shelter, and core-relief item assistance

Beneficiaries: 300,000 individuals

- **USD 22 million** is needed to respond to the dire shelter needs and provide emergency support to IDPs, including through the distribution of shelter kits, the provision of tents and collective shelters, site preparation and maintenance, as well as private shelter support.
- **USD 9.5 million** is urgently needed to provide core-relief items (CRIs) to vulnerable IDPs and affected host community members. CRIs include blankets, mattresses, kitchen sets, plastic sheets, jerry cans, sleeping mats, hygiene kits, solar lamps, and rechargeable fans.
- **USD 6.5 million** is needed to continue the emergency protection response including through the establishment of satellite community centers, the deployment of mobile units, and the continuation of legal aid services to vulnerable people on civil documentation, gender-based violence, child protection, and housing, land and property (HLP) rights.

Jordan – USD 29.6 million for protection, registration, shelter, core-relief item, health and WASH assistance:

Beneficiaries: 20,000 individuals

- **USD 18 million** to assist refugees with appropriate emergency shelter support.
- **USD 2.9 million** for water and sanitation services, including WASH facilities (toilet, shower, and holding tanks) and WASH CRIs (jerry cans and hygiene kits).
- **USD 1.2 million** to ensure the physical protection and security of persons of concern by providing security assessments, analysis, and advice in developing and implementing effective strategies which underpin the responsibilities of the Host Government.
- **USD 4 million** for the provision of CRI package in areas where access to safety is granted.
- **USD 1 million** is required to provide emergency protection services, including undertaking registration activities using biometrics to facilitate the identification of the most vulnerable and undertake referrals to protection staff. This also includes the identification and monitoring of key protection risks; advocacy for the most vulnerable to access appropriate services; dissemination of information to communities on protection services; and the establishment of mobile protection response services, including child protection and sexual and gender-based violence (SGBV) case management services, if the situation permits it.
- **USD 0.5 million** for camp coordination and camp management (CCCM) activities, including the provision of accurate and timely data on population movements, the coordination of multi-sectoral response in areas where access to safety is granted, and work with the Government of Jordan in facilitating security in all sites.
- **USD 2 million** for health and nutrition assistance, including prepositioning stocks of medication and medical supplies; the establishment of an Epidemiological Surveillance and Early Warning and Response System; the establishment of mobile medical units, including for reproductive health services; to ensure provision of clinical management of rape services; and establishment of a 24/7 referral system.
