




# **Total Population:** 13,416 Individuals with 7.917 Cases




\*Below the age of 18 years old \*\* Above the age of 59 years old






# **Monthly Statistical Report** June 2021

#### **Children Registered with UNHCR**

At the end of June some 3,622 children were registered with UNHCR, including 3,508 children in families, 77 children who are unaccompanied by a parent or other adult relative, and 37 children who are separated from their parents but living with an adult caregiver. Together with our partners, UNHCR is working to ensure all refugee children have access to an education, and as of June some 700 refugees were enrolled in accredited national schools.

### Persons Registered with UNHCR in Detention and Alternatives to Detention

Some 19 persons registered with UNHCR, or less than 1 percent of the population were in immigration detention at the end of June, none are children and woman. UNHCR continues to advocate to end the detention of refugees in Indonesia and for those being detained to be released to alternative arrangements including placement in community accommodation, periodic reporting mechanisms, or community supervision. As of end-June, alternative accommodations were being provided for some 7,725 individuals (of whom 79 were unaccompanied or separated children).
